

A collaboration of support

This spring nervous primary, middle school, and high school students who come to the Nebraska Wesleyan campus in Lincoln to deliver their "History Day: Nebraska" presentations at the state contest will have one less worry.

he NSHS Foundation, in collaboration with the NSHS, and with support from the Nebraska Humanities Council, will subsidize participant fees.

Expenses incurred by state contest winners who go on to the national contest in College Park, Maryland, will be partially deferred by Foundation funds and by a grant from the Nebraska Humanities Council.

The state event brings three hundred Nebraska students from seven districts to the Wesleyan campus to present essays, projects, media presentations, and performances. Judges from the NSHS and area schools, colleges, and universities evaluate the students' work and select the state winners who will represent Nebraska at National History Day.

The History Day theme is "Triumph and Tragedy in History." Students will explore local or regional connections to the larger theme, a process that helps them come to see American history as related to their own lives.

Perhaps no program in grades 6–12 engages students more directly with the past than does History Day. The program allows students to formulate theses, conduct research using primary and secondary sources, test their hypotheses against research results, and articulate their conclusions clearly.

In 2005 the NSHS Foundation established a special fund to support the event with an initial principal of \$20,000, and continues adding to it with contributions from private and public sources. With partial support from the Foundation's Gladys M. Lux History Education Fund, state winners now can be awarded \$100 travel stipends for the national competition. The Nebraska Humanities Council will add an additional \$50 per student.

This year's National History Day: Nebraska event will be held April 21, 2007. Winners will represent Nebraska at the national contest June 10–14.

ort Robinson, west of Crawford, Nebraska, was an active U.S. Army post from 1874 to 1948. Now a Nebraska state park and the site of a NSHS branch museum, few places can provide a more storied backdrop for the study of Western history.

April 26-28, 2007, the fort will host the sixth Fort Robinson History Conference, cosponsored by the Nebraska State Historical Society and the Nebraska Game and Parks

Commission, focusing on the theme "Fourlegged Soldiers: The Horse and the Mule in the Plains Wars and Beyond."
