HISTORICAL NOTE

Nuckolls County, Nebraska was organized June 27, 1871. It is located on the southern border of Nebraska bounded on the north by Clay County, on the east by Thayer County, on the west by Webster County. The Oregon trail ran through Nuckolls County along the course of the Little Blue River. The county encompasses an area of 576 square miles or 367,534 acres.

The first meeting of the Board of Commissioners was on June 27, 1871. Nelson was made the county seat and a courthouse was constructed there in 1873. A newer courthouse was constructed at Nelson in June of 1890 after a heated county seat fight.

The population in 1880 was 4,235 persons. It reached its peak in 1920 with a total of 13,236 residents.

Six railroads have serviced Nuckolls County. The Missouri Pacific had passenger service from Kansas to Superior, 1887-1971, but currently has only freight service through the county. The Fremont, Elkhorn and Missouri Valley Railroad was completed to Superior by May 1880. Passenger service on this line was discontinued in 1935 and the lines of this road are now abandoned. The Atchison, Topeka, and Santa Fe used the lines of the above road through Nuckolls County and provided passenger service until the 1930's. The county seat was served by a branch of the Rock Island, 1887-1920. It provided passenger service to Kansas City and freight service to Fairbury, Lincoln, and Beatrice. Portions of the line have since been removed. The Burlington was the main service road through Nuckolls County. This road constructed lines through the county in the 1880's. The last passenger train traveled through the county in March of 1958 and only minor freight services are now provided.

The county was named after Stephen F. Nuckolls of Nebraska City, Nebraska.

SCOPE AND CONTENT NOTE

This collection consists of the records of Nuckolls County, Nebraska, arranged into ten subgroups: 1) Treasurer, 1869-1965; 2) Assessor, 1885-1965; 3) County Board of Commissioners, 1885-1922; 4) County Clerk, 1871-1947; 5) Register of Deeds; 6) County Court, 1877-1897; 7) District Court; 8) Superintendent of Schools; and 9) School District Records, 1872-1875; 10) Soldiers' Relief Commission, 1891-1942; and 11) Municipal Records, 1873-1935.

The bulk of this collection exists in Subgroup One, County Treasurer. This subgroup has been partially microfilmed and is divided into six series: 1) Tax Lists, 1871-1965; 2) Delinquent Tax Lists, 1869-1935; 3) Tax Sale Records, 1871-1910; 4) Special Assessments, 1916-1940; 5) Motor Vehicle Tax Lists, 1935-1945; and 6) School Land Records, 1873-1967. Series one and two are entirely on microfilm. Series three contains one volume not filmed, 1871-1887. Series four, Special Assessments, has an additional volume not located at the time of filming, 1918-1935. Series five, Motor Vehicle Tax Lists, have been microfilmed and series six, School Land Records has not.

Subgroup Two, Assessor, consists mostly of 5-yr samples of assessments for the years between 1935-1965. Also included are miscellaneous railroad assessment records, 1885-1930.

Subgroup Three, County Board, consists of small filing boxes of miscellaneous document and correspondence submitted to the board for action regarding courthouse construction, county officials' reports, and miscellaneous railroad records, 1887-1907.

Subgroup Four consists of miscellaneous volumes of the county clerk's office, 1871-1947 including an officials' directory, 1871-1882 and a mark & brand records, 1880-1899.

Subgroup Five, Register of Deeds, consists of Numerical Index volumes for city lots and lands, 1872-1890, and one volume registering original land entries, 1869-1885.

Subgroup Six, County Court consists of seven Justice of the Peace dockets, 1877-1897.

There are currently no records in the State Archives for Nuckolls County District Court, Subgroup Seven. This includes records of Naturalization filings in District Court.

There are currently no records on file for Subgroup Eight, Superintendent of Schools.

Subgroup Nine, School District Records, is divided into one series: 1) School District #8, 1872-1875.

Subgroup Ten includes minutes of and claims filed with the Soldiers Relief Commission, 1891-1942.

Subgroup Eleven, Municipal Records, contains one jail register, 1879-1935 and one magistrate's docket, 1873-1877.

The School District Records were received by the Archives in August of 1965. The remainder of the collection was transferred to the Archives from county offices May 11, 1977. The Tax Lists of Subgroup One were microfilmed by the Historical Society in 1991.
