HISTORICAL NOTE

The Territorial legislature of 1856 created the boundaries of present Thayer County but it was originally known as Jefferson County. The legislature also created Jones County which corresponded with the boundaries of present Jefferson County. The two subdivisions were combined in 1867 and the name Jefferson County was retained. When the legislature of 1870-71 again divided the large county into two, present Thayer County was named in honor of Gen. John M. Thayer, Nebraska Civil War General.

SCOPE AND CONTENT NOTE

This record group consists of the records of Thayer County, Nebraska, arranged in the following series: (1) Justice Dockets, 1871-1921.

These records relate to the activities of the Justice of the Peace for Thayer County, Nebraska, 1871-1921. They were A.T. Hobbs, and Joseph Lamb.

These records were maintained in custody of J. Lamb until 1932 when they were transferred to the Society.
