HISTORICAL NOTE

In 1935, a bill was enacted that was "designed to promote the horse breeding industry in Nebraska" and establish a commission of three persons appointed by the governor for three-year terms. The State Racing Commission has the "power to prescribe and enforce rules and regulations governing horse races and race meetings licensed" according to law.

The State Racing Commission consists of three members appointed by the Governor from each congressional district. They meet monthly and receive no salary but are reimbursed for expenses.

SCOPE AND CONTENT NOTE

This collection contains the records of the Nebraska State Racing Commission since its formation in 1936. It is an open collection and is continually expanded.

The collection is arranged in four subgroups: 1) Administrative Correspondence, 1935-1975; 2) Track Records, 1935-1976; 3) Brood Mare Records, 1951-1974; and 4) Nebraska Thoroughbred Breeders Association, 1949-1976.

Subgroup One, Administrative Correspondence, contains correspondence and records of the Nebraska State Racing Commission administrative offices, 1935-1975. Included are annual reports and minutes of the State Racing Commission. Series Two consists of minutes of the Racing Commission as microfilmed by the Secretary of State's office. The film was copied from security microfilm stored in the Archives department.

Subgroup Two, Track Records, 1935-1976, is divided into three series: 1) Annual Reports & Correspondence, 1935-1974; 2) Official Programs, 1935-1976; 3) Daily Reports, 1956-1972; and 4) Track Booklets and Miscellany, 1935-1974 & n.d. Series One contains correspondence and annual reports of the various tracks in Nebraska. Series Two contains the official programs of the Nebraska racing tracks, 1935-1976. Series Three contains the daily reports (statistical and financial) of the different race tracks.
