

FEES FOR DUPLICATION & SPECIAL ACCESS

NEBRASKA STATE HISTORICAL SOCIETY

(effective August 1, 2007)

Providing access to its collections is part of the mission of the Nebraska State Historical Society. While on-site access is generally free of charge, any access that requires staff research, lab work or special curatorial assistance involves charges. For a fee, the NSHS also provides duplicates of photographs, documents and published materials in its collections, copies of moving images and sound recordings, and images of artifacts, spaces and activities of the NSHS. This schedule outlines the fees the NSHS charges for duplication and special access.

Permissions and use fees. Permission for the use of the duplicates obtained from the NSHS is granted at the NSHS's discretion and documented in an agreement between the NSHS and the user. For details on the NSHS's guidelines for use, see [Use Policy](#). For some uses, additional use fees may be involved (see [FEES FOR THE USE OF STILL IMAGES](#) or [FEES FOR THE USE OF MOVING IMAGES AND SOUND RECORDINGS](#)).

Delivery times. Standard delivery time is within two weeks of receipt of payment unless otherwise stated. Larger orders or quantities may require more time; consult with Reference Staff when placing such an order. Rush services (delivery within five business days) may be possible dependent on staff availability, and are charged double the fees posted below.

Payment. Duplication and special access fees must be paid or invoiced in advance of delivery of orders and are non-refundable. Nebraska state agencies must pay through IBT. Fees are subject to change without notice.

Right of refusal. The NSHS reserves the right to refuse to duplicate items in its collections due to condition or restrictions imposed by donor agreements or law (including copyright).

Waivers. The NSHS reserves the right to waive fees or other requirements on an individual basis at the discretion of the Society's Director. Such waiver of fees can be made only upon approval of written application.
